1 1/8 MILES. (1.40) 1/4 5TH RUNNING OF THE REBEL. Grade II. Purse \$600,000 THREE YEAR OLDS. By subscription of \$300 which shall accompany the nomination, original nominators paying \$3,000 to pass the entry box and \$3,000 additional to start. Supplementary nominations may be made by the closing time of entries at a fee of \$7,500 which qualifies to start with \$600,000 Guaranteed of which 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally among all other starters. **WEIGHTS:** 122 lbs. Non-winners of \$60,000 at a mile or over in 2014 allowed 3 lbs.; \$50,000 at a mile or over anytime allowed 5 lbs.; \$35,000 at any distance allowed 7 lbs. (Maiden and Claiming races not considered.) In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Early Bird closing Friday, February 7, 2014 at \$500 for The Southwest, The Rebel and The Arkansas Derby. Certain finishing positions in this race will earn points to qualify for the 2014 Kentucky Derby, pursuant to the official rules for the Road to the Kentucky Derby published by Churchill Downs Incorporated. Closed Friday, March 7, 2014 with 95 nominees.

HOPPERTUNITY within striking distance from the start, stalked three wide up the backstretch, came four wide into the lane, brushed with TAPITURE when that one came out looking for room three sixteenths out, continued under pressure, came in slightly past the furlong marker to tighten up inner rivals, proved narrowly best in game fashion. FOLLOWING A CLAIM OF FOUL BY THE RIDER OF TAPITURE AGAINST THE WINNER FOR ALLEGED INTERFERENCE IN MIDSTRETCH AND A STEWARDS' INQUIRY REGARDING THE STRETCH RUN, THE RESULT WAS ALLOWED TO STAND. TAPITURE in the second flight while under restraint, bit closer into the lane, made hole three sixteenths to run, brushed, tight late, outkicked. RIDE ON CURLIN dueled up front along the inside, continued to vie up the backstretch, asked, drifted out bit midstretch, brushed, not enough in the late going. STRONG MANDATE broke on top, alternated up front off the inside, narrowly showed the way through the second turn, in tight, squeezed back a furlong out, well clear of the others. SHELTOWEE'S BOY settled off the pace, two path into the lane, steered out bit, finished up evenly, no real threat. STREET STRATEGY four wide in the first turn when forwardly placed, widest backstretch, weakened in the drive. KOBE'S BACK off slowly, rank when getting into the first turn, was never a factor. JET CAT finished early, trailed home while well beaten.
